2. TECHNICAL SPECIFICATION:

- i. Purity(Assay) Not less than 99.5%v/v
- ii. Carbon dioxide not more than 300ppm v/v
- iii. Carbon monoxide not more than 5ppm v/v
- iv. Water vapour not more than 67ppm v/v
- v. Incoming ISO containers should not be at a pressure exceeding 5 Bar at the time of decantation.

Note: The supplier shall be responsible for the quality of goods. The purchaser reserves the right to reject the goods if found not meeting the quality as prescribed above.

- iv. Insurance Certificate and documents also to be submitted for payment of LC:
